"St. John's School was founded in 1952 in order to provide an advanced educational opportunity to the residents of Guam ..." These words from our school's mission statement define our purpose in simple terms. Additionally, our mission is to "provide the highest quality academic and extra-curricular education...for students who plan to continue to higher education."

It is our goal to attract the brightest students from a broad range of backgrounds—students with strong academic promise and the motivation to succeed. Income from our Endowment Fund, combined with contributions from individual donors, helps us provide the St. John's quality education through financial assistance to qualified students.

Financial assistance provided to St. John's families is strictly confidential. The Board of Trustees determines policy guidelines and funding amounts, but only the school administration reviews applications and determines awards.

Scholarship students and their parents are expected to volunteer their time and talents to provide services needed by the school.

## **Programs Available**

**General Scholarship** - Awarded to the most qualified students based on financial need, academic standing and other personal achievements. Candidates must complete the financial aid process, as enclosed. Award amounts vary based on the pool of candidates and the availability of funds.

**ECIM Scholarship** – Established in 2008 by The Episcopal Church in Micronesia (ECIM) and the national Episcopal Church in New York, this scholarship is based on financial need, academic standing and other personal achievements. This scholarship is an outreach program for Episcopalian students who wish to benefit from a college-preparatory education. Candidates must complete the financial aid process, as enclosed. Award amounts vary based on the pool of candidates and the availability of funds.

**Merit Scholarship** - Established in 2004 by St. John's School Board of Trustees, this scholarship is for talented students who show potential in any of these areas: sports, visual arts, performing arts, leadership and community service. Merit scholarships are awarded independent of financial need. Students must remain in acceptable academic standing throughout the school year.

**Benefactor Scholarships** – St. John's has a donor-centered giving program in which donors may create special scholarships or scholarship endowments. These scholarships may or may not be offered each year depending on the availability of funds. Interested students need not apply directly for these scholarships as all candidates in the Tuition Assistance Program are automatically considered.

## Eligibility for the Tuition Assistance Program

- ✓ Student applicant must have been a resident of Guam for the past year. (Except for ECIM Scholarship)
- ✓ New Merit Scholarship applicants must first be accepted for enrollment before applying.
- ✓ Current student applicants must be in good standing at St. John's School.
- ✓ New applicants must show excellent grades from previous school and must exhibit special talents, achievements, or the potential for high achievement.

## Application Process

The applicant will complete the Tuition Assistance Program Application Form and:

- ❑ If not a current St. John's student, provide official transcripts of grades from the past two years mailed directly from their school, along with most recent standardized test scores (SAT, ACT etc.)
- ❑ Provide a list of his/her special talents or achievements in the areas of sports, music, visual or performing arts, or community service.
- ❑ For new applicants, write a 250-word essay outlining, ***"Why St. John's School is right for me"***.
- ❑ Provide a letter of recommendation from a special teacher, coach, or counselor who knows the student well. For ECIM applicants, obtain a letter of recommendation from the Vicar.
- ❑ Complete the application process for St. John's School and be available for a personal interview if asked. All Tuition Assistance will be awarded after admission and enrollment to St. John's School. Tuition Assistance awards are not transferable or deferrable.

Applications and supporting documents must be submitted to the Business Office at St. John's School. **Deadline for applications is on or before February 28, 2018 for the upcoming academic year. (Early submission is encouraged)**

The Financial Aid Committee and Head of School will review applications. Recipients of scholarships will be notified in a timely manner possible.

3. **REVIEW** Process:

- School and Student Services (SSS) will provide St. John's with a Statement of Parental Contribution based on information provided in PFS.
- St. John's Financial Aid Committee will review SSS recommendation and will make final decision on awards.

4. **AWARD or DECLINE**

- Upon completion of review process, the Head of School will send a letter of AWARD or DECLINE. Applicants who are awarded financial aid must respond within 15 days from date of letter.
- Upon acceptance of the financial aid award, the Business Office will finalize enrollment contract for School Year 2018-2019 to reflect grants awarded.

Step 1: Log on to [www.nais.org](http://www.nais.org)

Step 2: Select: SSS tab located in the top row

Step 3: Select: Login to Complete or Update Your Parents' Financial Statement (PFS)

Step 4: Create a new account for new applicants or log in for returning families/existing account users.
